- 2. Reading of Conflict of Interest Statement Taft Morley

- a. March Budget Update
  - i. The anticipated surplus is close to \$300K as of end of March. Will continue to be cautious with budget for the remainder of the year with the goal of staying in the surplus by fiscal year end.

  - iii. We have another audit approaching and the field work will be out of Acadia. We have used Jay Sharp in the past and have been satisfied with his work. Mr. Sharp's price will increase this year because he will be completing the tax portion as well.
